On the latest well test, 11-16-63, this well flowed 7 BOPD and no water with a GOR of 5,000 through a 30/64" choke. The Gamma Ray Neutron log indicates several zones of porosity in the Upper Drinkard which have not been tested. It is proposed to perforate the intervals at 6523, 6530, 6537, 6545 & 6552' w/1 JSPP and fracture with 20,000 gals lease crude, 1000# ADM-ITV additives & 20,000# 20-40 sand.

Instructions
