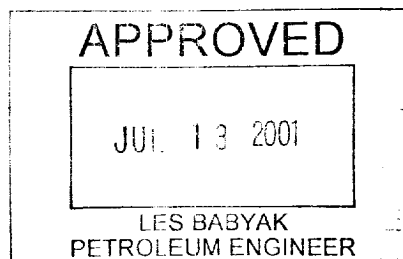

- 4.) Downhole commingle production from all three pools.
