We forward herewith application in triplicate for approval of a 120-acre non-standard gas proration unit for our Hawk B-1 Well No. 6, located in Unit N, Section 9, T-21S, R-37E, Lea County, New Mexico. This Blinebry gas proration unit is being reduced in size due to the recent completion of our Hawk B-1 Well No. 4 as a Blinebry oil well located in Unit L. It is our present intention to continue completing wells in this quarter section in the Blinebry Oil Pool so that eventually the entire acreage will be developed for Blinebry oil.

In order to eliminate the necessity for successive applications which would be an administrative burden for your staff as well as ours, it is respectfully requested that future reductions in the size of this unit be effected by the filing of Form C-102, indicating the revised size and shape of the proration unit.

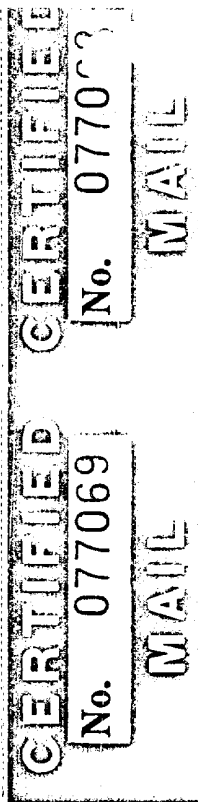

Gentlemen:

Re: Continental Oil Company Application for a non-standard gas proration unit for its Hawk B-1 Well No. 6 in Section 9, T-21S, R-37E, NMPM, Blinebry Gas Pool, Lea County, New Mexico

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 5 (C) of the Special Rules and Regulations for the Blinebry Gas Pool of Order No. R-1670 for the formation of a non-standard gas proration unit consisting of the S/2 SW/4 and NE/4 SW/4 of Section 9, T-21S, R-37E, for its Hawk B-1 No. 6 well located 660 feet from the south line and 1980 feet from the west line of Section 9, T-21S, R-37E, Lea County, New Mexico, in the Blinebry Gas Pool.


In support of this request we should like to point out that the proposed unit conforms with the requirements of said Rule 5 (C) in all respects as follows:

1. Said proposed non-standard gas proration unit consists of contiguous quarter-quarter sections.
2. Said proposed non-standard gas proration unit lies wholly within a single governmental quarter-section.
3. The entire proposed non-standard gas proration unit may be reasonably presumed to be productive of gas.
4. The length or width of said unit does not exceed 2,640 feet.
5. Copies of this application have been furnished this date by registered mail to all operators in the same quarter-section and all operators within 1,500 feet of said well, as required by the provisions of said Rule 5 (C).

A plat is attached hereto showing to the best of our knowledge and belief the proposed unit, the location of the No. 6 well and other wells on the lease, offset wells and ownership thereof.

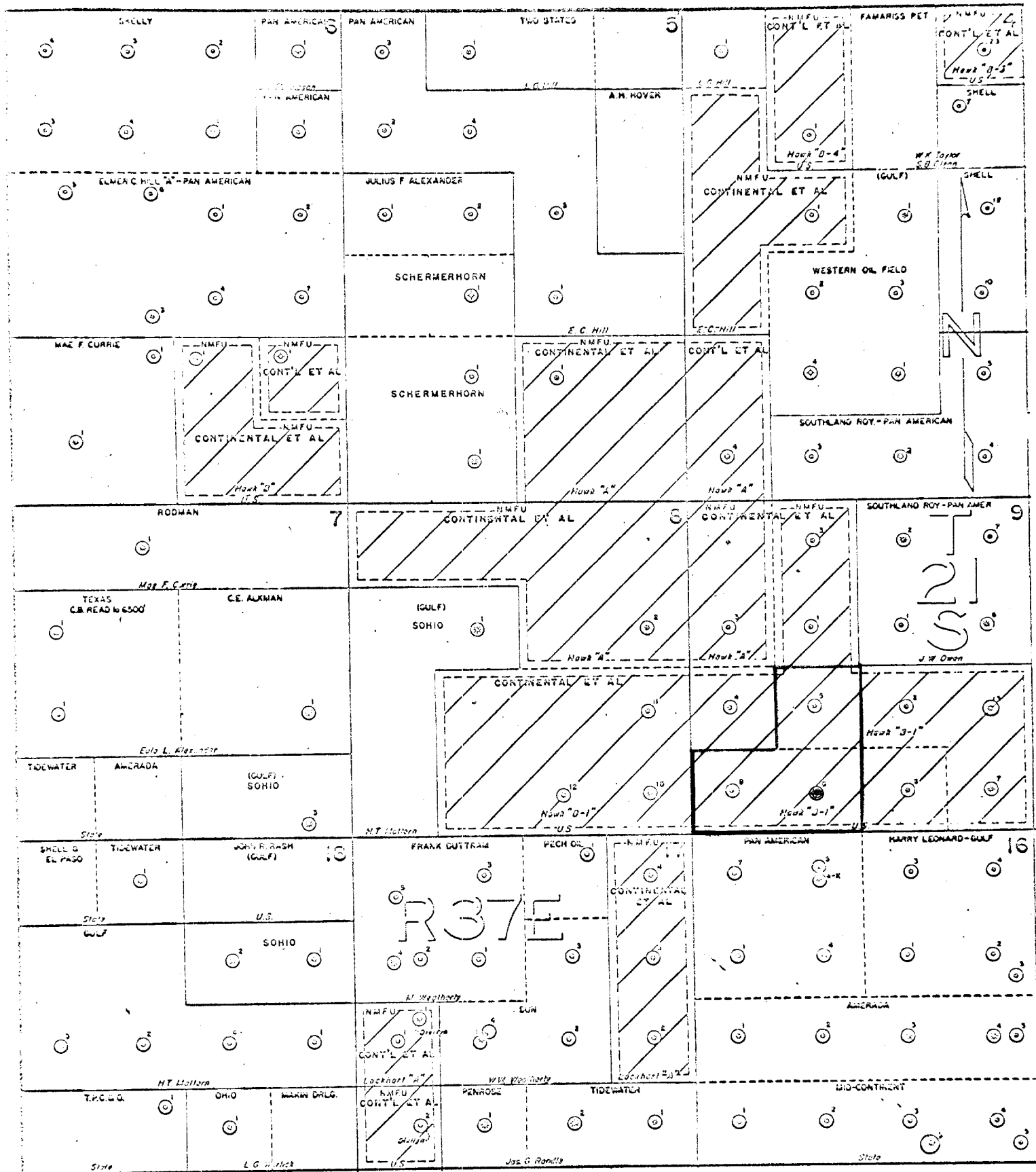
The granting of this application is in the interest of preventing waste and the protection of correlative rights.
