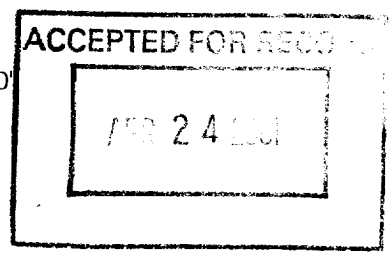
2/7/01 Release packer & RBP and pull up hole. Set RBP @ 6100' & packer @ 5650'

2/8/01 Acidize Blinebry 5674-5986 w/ 7000 gals 15% HCL

2/12/01 Frac Blinebry 5674-5986 w/ 41450 gals gel & 80000# 16/30 sand

2/15/01 Run in hole w/ retrieving head. Tag sand @ 5819'. Wash sand & circulate hole clean

2/16/01 Release RBP and pull out of hole. Run in hole w/ 2-7/8" tubing and set @ 6448'. Return to production
