FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Hawk B-9 No. 5 was completed 6-22-48 at a total depth of 6707'. It was completed in the Drinkard formation with the interval 6696-6706' perforated. During the month of June 1960 this well produced 15 bbls. oil per day, 0 water W/180 MCFGPD.

We propose to run 2" tubing plug by wireline and set below PKR, kill Tubb zone, run 2" tubing to Drinkard zone, run 2" tubing W/beveled collar for Tubb zone, treat Tubb zone W/500 gals MCA and 5000 gals LSTNE acid, swab Tubb zone and place on production, remove TBG plug from Drinkard zone and place on production.
