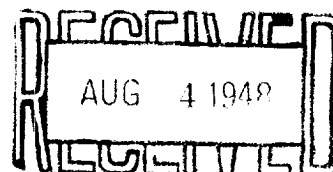

Washed open hole 6460 to 6610 with 500 gallons mud acid. Acidized open hole 6460 to 6610 with 1500 gallons 15% acid. After recovering oil and acid load, flowed on O.P.T. 240.18 barrels oil, cut 0.6% BS through a 48/64-inch choke in 24 hours. Gas oil ratio 960.
