BJ Service cemented 5-1/2" w/438 sx 1:1 mix Incor-Diamix + 4% gel + 2% Ca Cl, followed by 100 sx Incor neat + 2% Ca Cl. Plug down @ 4:00 p.m. 1/11/63. Full returns while cementing. WOC 35 hrs. Tested 5-1/2" casing w/1500# for 30 min. Held 0.K. Cored & drilled 4-3/4" hole from 3786' to 3948' T.D. Treated Grayburg open hole 3782' to 3948' w/750 gallons 15% LSTNE HCl acid. FBIP = 1900#. Avg T.P. = 1900#. Avg Inj. Rate = 6 BPM. Job complete @ 3:00 A.M. 1/30/63.


