ADDITIONAL INFORMATION (If recompletion give full details of proposed plan of work.)

The present producing zone is 5179 - 5185', has become uneconomical to operate. We would like to set a bridge plug at 5000' and perforate the Penrose Skelly Grayburg from 3578 - 3765', 3790 - 3800', ~~3807~~ 3807 - 3810' with 2 jets per foot. We then plan to acidize with 2000 gallons and frac with 10,000 gallons water and 10,000# sand if necessary.
