Set plug in "R" Nipple at 10,517.05' in long tubing string. This plugged off Strawn Zone. Opened sleeve at 10,480' in long tubing string which opened Wolfcamp Zone into long tubing string.

Swabbed well in. Well now producing with Wolfcamp Zone producing through tubing string with Strawn Zone plugged off.
