Spudded at 11:00 P. M. 1-1-65. Drilled a 17 1/2" hole to 1190'. Ran and set 13 3/8" OD 48# H40 R-2 casing ST&C New to 1189.20' KB (1169.70' casing in ground). Cemented with 1000 sax of 50-50 Lite Wate Posmix and 200 sax of neat cement + 2% cc by Dowell. Plug down at 9:15 P. M. 1-3-65. Circulated cement. WOC 24 hrs. Tested casing to 800# and held for 30 min. Pressure after 30 min. was 800#.
