1. Drilled 8-3/4" hole to 10,817'.
2. Ran Gamma-Ray Sonic and Dual Induction Laterolog.
3. Ran 5-1/2" casing on 2-14-65 with Baker Model "G" fill-up collar and diff. fill-up guide shoe as follows:
 5-1/2", 17#, M-80, Surf. to 3079'
 5-1/2", 17#, J-55, 3079' to 5028'
 5-1/2", 15.5#, J-55, 5028' to 9284'
 5-1/2", 17#, J-55, 9284' to 10,418'
4. Cemented casing at 10,418' with 235 sacks Trinity Lite-Wate and 160 sacks of Incor. Ran Temperature Survey and found cement top at 7500'. WOC 24 hours.
5. Nipped up wellhead and tested casing to 3000 psi for 30 minutes - Held OK.
6. Preparing to run 2-7/8" EUE tubing and perforate Wolfcamp reservoir.
