Set 8-5/8" 24# J-55 casing @ 1265', and cemented with 480 sacks Class "C" with 4% Gel and 2% Cacl and 100 sacks Class "C" with 2% Cacl. Circulated an estimated 200 sacks. WOC 24 hours, tested casing with 1200# for 30 minutes, no drop in pressure.
