- 1) Drilled 8-1/2" hole to 11,800'.
- 2) Ran BHC Gamma Ray Sonic, Compensated Density Correlation Neutron, Dual Indication Electric, and Micrologs 4750-11,800'.
- 3) Set 301 joints (11,779') 7-5/8" OD 33.04# casing at 11,800'.
- 4) Cemented with 1200 sacks lightweight cement, 0.5% CFR-2, 200 sacks class H cement with 3% salt, 1.5% CFR-2. Cement failed to circulate.
- 5) Ran temperature survey and found top of cement at 4715'.
- 6) Drilled out cement to 11,800'. Tested casing to 2000'; held okay.
- 7) Resumed drilling.

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
