Class "C" cement + 10# salt per sx. cmt., max. cmt. press. 1800#, had good returns while cementing and WOC at 10 AM 7/3. Moved in completion unit 7/8/74. Plan to perforate the Seven Rivers zone 3912 to 3960' interval and acidize same W/2000 gals. of 15% HCL acid
