1. MIRU. ND wellhead. NU BOP. Rlse f/ pkr. POOH laying down 2-3/8" tbg. Change pipe rams to 2-7/8".
2. RIH w/ fishing tools. Mill out & pull pkr f/ 13,575'. POOH.
3. RIH w/ fishing tools. Mill out pkr @ 13,630'. Push remainder of pkr to PBTD @ 14,168'. POOH w/ tools.
4. RIH w/ RBP & pkr. Test csg to 1,000 psi. Establish injectivity test into perfs 13,734'-84'. POOH.
5. Run logs as necessary to aid stimulation design.
6. Set CIBP @ 13,885' & cap w/ 10' cmt. Set CIBP @ 13,815'. Set CICR @ 13,535'.
7. Cement squeeze perfs 13,734'-84'.
8. Drill out CICR & cmt to 13,790'. Pressure test cmt sqze. Finish drilling out cmt & CIBP @ 13,815' and push to "new" PBTD @ 13,875'.
9. RIH w/ production pkr on 2-7/8" tbg. Set pkr @ 13,810'.
10. Acidize or fracture stimulate Morrow perfs 13,830'-52' as necessary.
11. Flow/swab test well for indication of productivity.
12. POOH laying down 2-7/8" tbg. RIH picking up 2-3/8" tbg.
13. Latch onto pkr @ 13,810'. ND BOP. NU wellhead. Place well on production. RD workover unit.
