Estimated starting date is April 1, 1992. Procedure is as follows:

1. MIRU well service unit.
2. Load tubing w/KCL water. Test annulus to 1000#.
3. Install BOP. Pull tbg. & seal assembly from packer @ 13,856'. Lay down approximately 9 jts.
4. Run gauge ring and set CIBP @ 13,700'+. Dump 2 sacks cmt. on BP w/bailer.
5. Perf. U. Morrow 13,617'-27' w/2 SPF using 3-1/8 gun.
6. Set drillable packer with pumpout plug on wire line @ 13,570'+.
7. Run tbg. and seal assembly. Space out tbg. Remove BOP and flange up well head.
8. Pump out plug and test well.
9. Acidize well w/1000 gals. 7-1/2% acid w/additives and ball sealers.
10. Test well.
11. Rig down well service unit and put well on production.
