Estimated starting date is October 1, 1991. Procedure is as follows:

- 1) MIRU well service Unit. Install BOP.
- 2) Pull tbgr. & seal assembly from Model "D" pkr.
- 3) Run GR/CCL from 13,600'±(TD) to 12,600'.
- 4) Set CIBP @ 12,550'. Dump 2 sks. cmt. on plug w/ bailer.
- 5) Perf. for squeeze 12,968' 1' 4 holes & 12,918' 1' 4 holes.
- 6) Set cement retainer @ 12,960'.
- 7) Run tbgr. & sting into retainer.
- 8) Circ. cmt. to retainer & spot across zone or block squeeze as necessary.
- 9) Run tbgr., bit & scraper & clean to PBDT (12,960'). Test squeeze.
- 10) Pull tbgr., scraper & bit.
- 11) Perf. Atoka 12,942'-46' 4 SPF.
- 12) Set drillable pkr. on W.L. @ 12,925', w/ pump out plug if necessary.
- 13) Swab well down.
- 14) Acidize w/ 500 gals. 7 1/2" acid with additives.
- 15) Recover load & test as necessary.
- 16) Frac. well if necessary.
- 17) Clean up well. R.D. well service unit and put well on production.
