On 12/22/84 ran 37 jts. of 8 5/8", 24#, K-55, STC Csg. (1498.27') with 8 5/8" float collar and an 8 5/8" Texas Pattern Shoe. Set csg. at 1496'. Cemented csg. with 200 sxs of Class C + 2% CACL2 at bottom. Cemented top with 530 sxs BJ Lite. Cir. Cmt. to surf. Pumped plug down with fresh water at 11.PM, 12/22/85 with 1250 PSI. WOC 30 hours. RIH with 7 7/8" bit and 6 1/2" DCS to 1459'. Test pipe rams to 1000 psi, held O.K., test hydril to 500 psi, held O.K. Test casing to 1000 psi for 30 min., held O.K. Resume drilling operations.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
