Attached is a copy of an administrative application for NMOCD approval of an unorthodox well location and simultaneous dedication in the Eumont YTS-7RVRS-QN (Pro Gas) Pool.

Chevron U.S.A. is planning to drill and complete the H.C. Collins #6 in the Eumont Gas Pool. The proposed well location is 890' FNL and 1810' FWL in Section 14 of T-21-S, R-36-E, Lea County, New Mexico. We have requested that the NMOCD approve the simultaneous dedication of this well with the H.C. Collins #4 which produces on an existing non-standard 320-acre Eumont gas spacing and proration unit (GPU). This GPU comprises the E/2 W/2 and the W/2 E/2 of Section 14 in T-21-S, R-36-E. Because the subject well location is less than 660' from the west boundary and less 990' from the north boundary of a 320-acre GPU, we have also requested NMOCD approval of an unorthodox well location.
