Tail w/ 300 sx Class 'C' + 1% CaCl. Bump plug @ 8 am. Press up pkr, drop dart, open DV tool, circ. Cement 2nd stage w/ 2000 sx 50/50 Poz + 10% gel + 8% salt. Tail w/ 200 sx Class 'C' + 1% CaCl. Plug down @ 2 pm. WOC. Will continue drilling 8 3/4" hole.
