The BLM approval of the APD for this well on 1-14-02 contained the following language in Section II. Casing, paragraph 1: "the 8 5/8 inch surface casing shall be set at 1350 Ft. or in the Top 25 Ft. of the Rustler formation and cement circulated to the surface." Alternative Conditions of Approval-Drilling were attached to the approved APD which would allow Apache to set surface casing at 400', but the phrase "or per the attached Alternative Conditions of Approval-Drilling" is missing from said Section II. I. We request, therefore, confirmation that it was the intent to include the missing phrase in Section II. I of the Conditions of Approval-Drilling.
