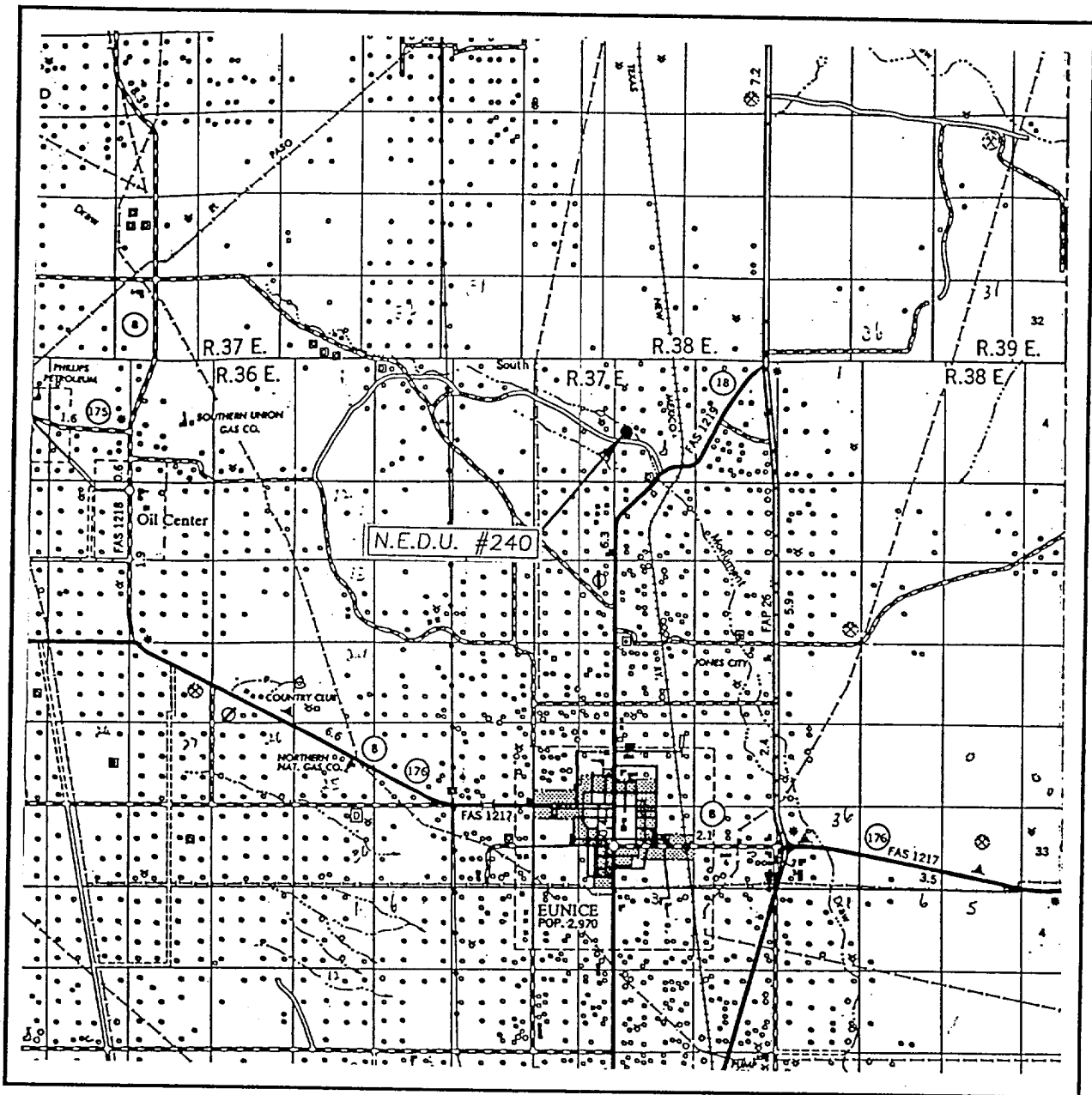

VICINITY MAP

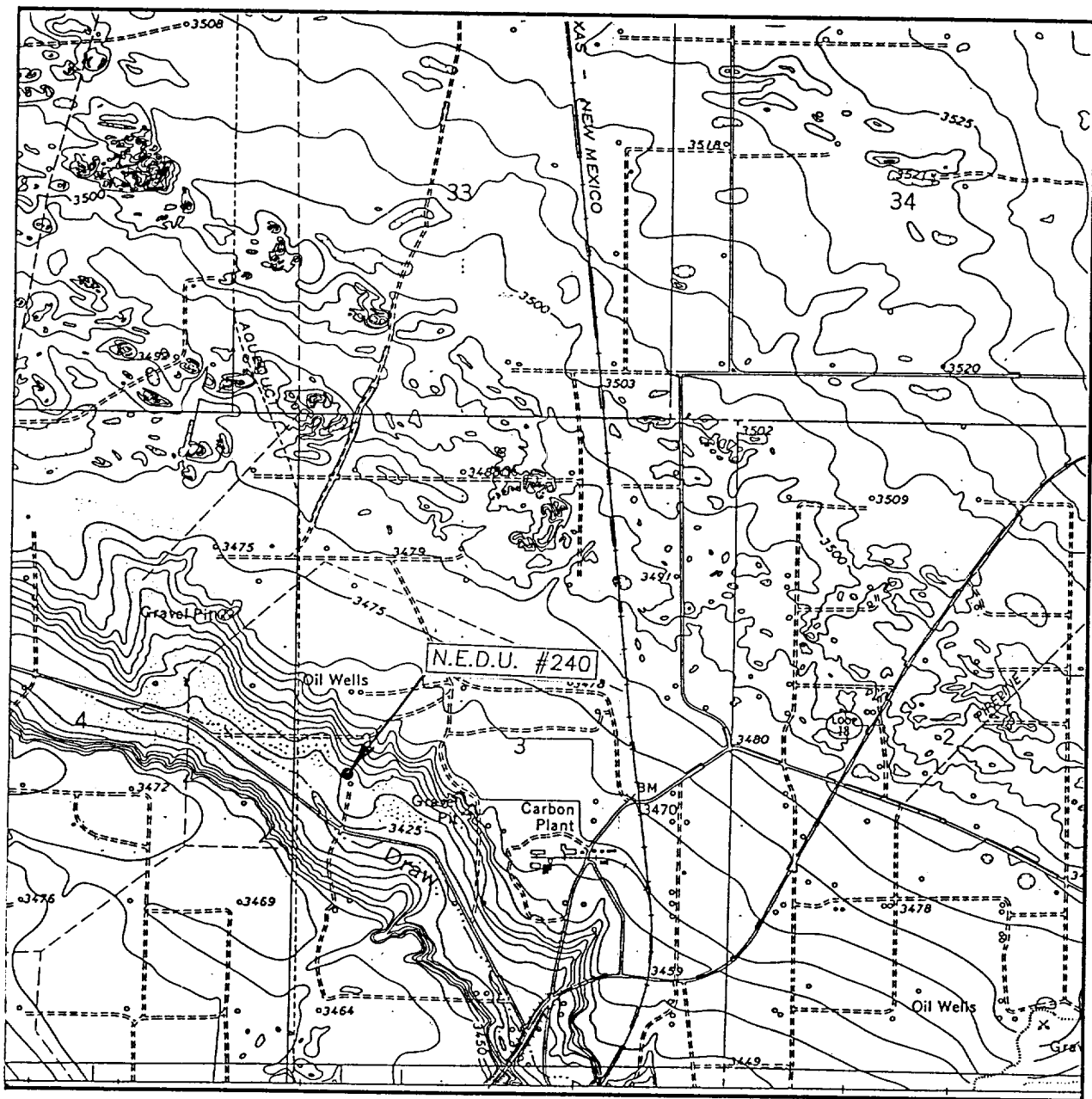

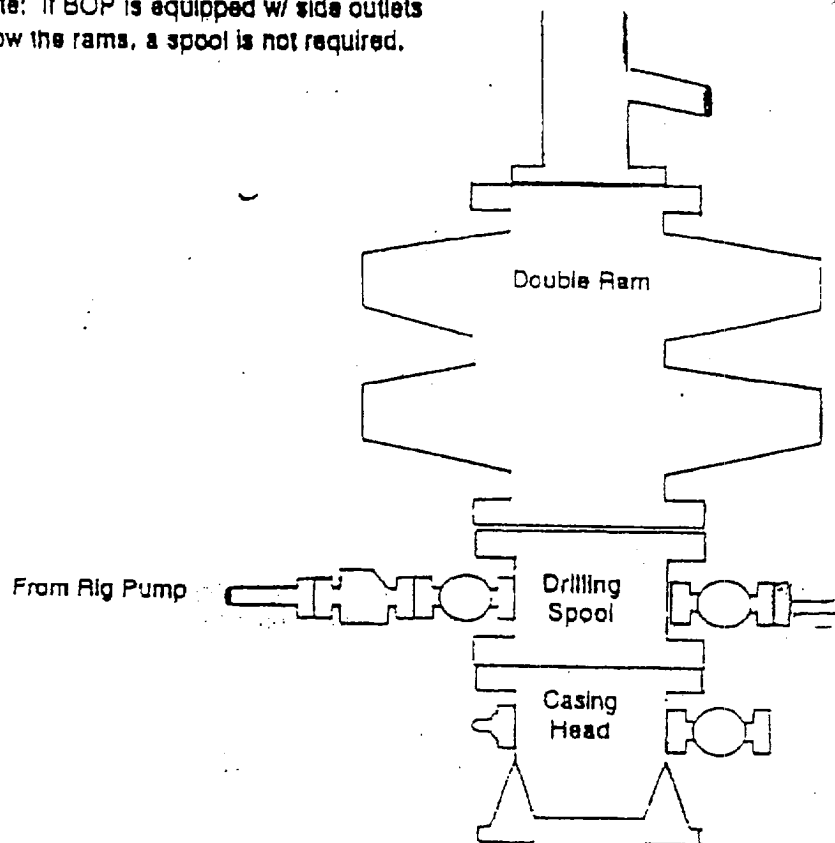

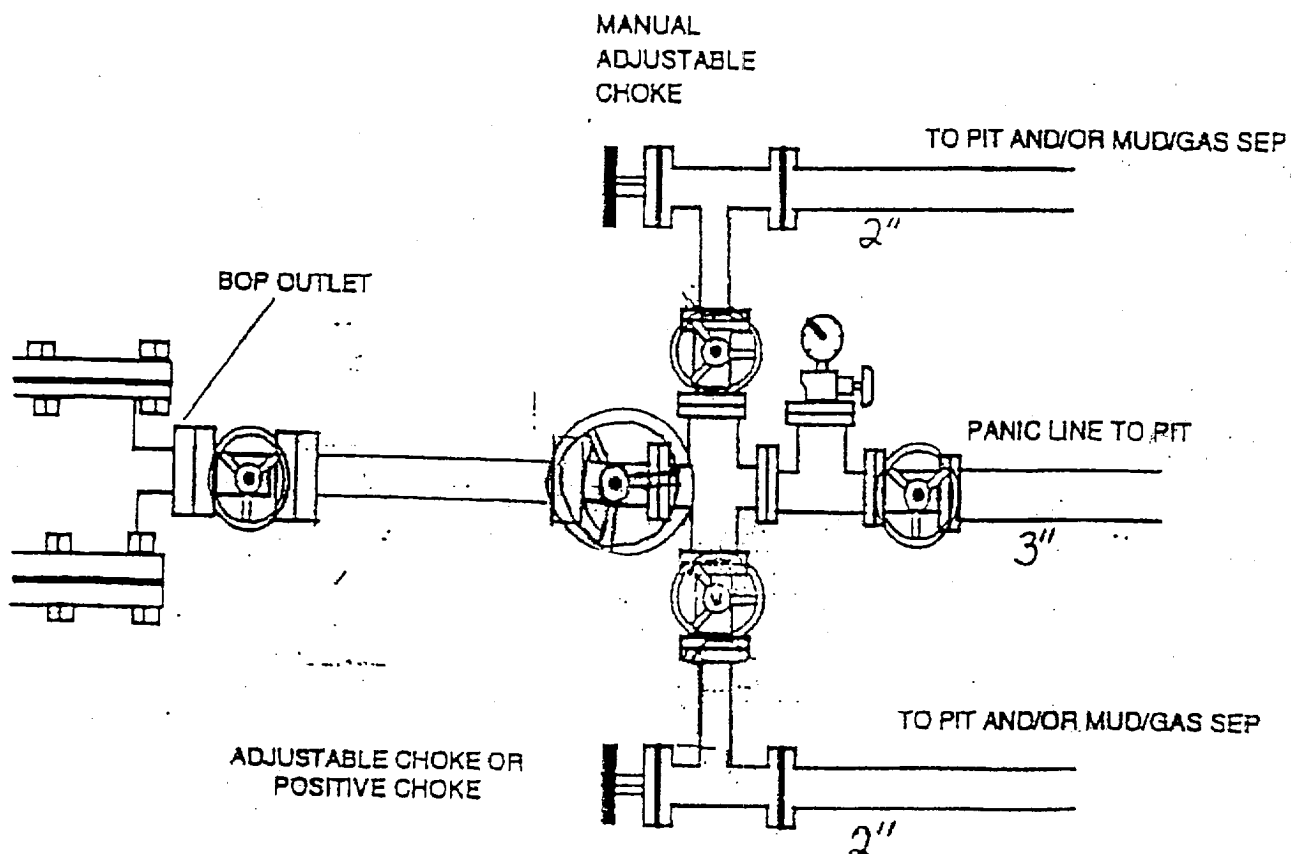
BOP Schematic
