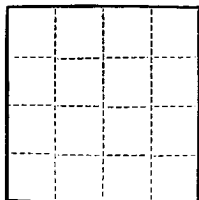

### DETAILS OF WORK

We plan to set approximately 320' of 8 5/8" surface casing with sufficient cement to circulate.
