1. Ran 2" tubing open ended to 3819', spotted 250 gallons 15% BDA, pulled tubing.
2. Perforated 4 1/2" casing @ 3683', 3704', 3712', & 3749' w/4-way jet.
3. Treated down 4 1/2" casing w/20,000 gallons lease crude containing 1.5% 20-40 mesh sand & 1/20# Mark II Adomite/gallon.
4. Cleaned out to 3819'.
5. Ran 123 jts. (3746') 2", 8rd thd, EUE, J-55, tubing & hung @ 3754'.
6. Recovered load.
7. On OPT flowed 144 BOPD (based on 39 BO in 6 1/2 hrs.) thru 12/64" choke. FTP 275 psi. CP 50 psi. Gravity 38.4 deg. API.


