 Ran 192' of 7-5/8" (24#, H-40, J&L) casing and cemented @ 204' with 130 sacks Class A with 2% CaCl₂. Plug down @ 7:00 p.m. (MST), July 16, 1961. Circulated out 10 sacks cement. After WOC 13 hours, tested casing with 1000 psi for 30 minutes - no pressure drop.

3. Approximate cement slurry temperature 60°.
