Effective January 1, 2002 Breck Operating Corp. shut-in this well because it was uneconomical to produce. Breck Operating Corp is proposing to set a CIBP @ 3600' with the top perf @ 3652' and then run a mechanical integrity test in preparation of requesting Temporary Abandon appoval. We will give the OCD and BLM 24 hrs notice before pressure testing casing to 500# for 30 minutes. A successful pressure test will be submitted to request Temporary Abandon status.
