DETAILS OF WORK

It is intended to drill a well with rotary tools at above location to an approximate TD of 3825'. Casing will be cemented in accordance with USGS standards and other special requirements will be complied with.

The following casing program is planned: 8 5/8" OD casing set at 350' with 350 sacks neat, cement to be circulated to surface: 5 1/2" OD casing set at TD with 900 sacks, cement to return to approximately 1200'. Depth and number of sacks of cement will be determined by caliper survey. Approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.


