DETAILS OF WORK

It is intended to drill this well with rotary tools at the above location to an estimated TD of 3800'. Casing will be cemented in accordance with U.S.G.S. standards, and other special requirements will be complied with.

The following casing pattern is planned: 8 5/8" OD set at 350' with 350 sacks, cement to circulate to surface; 5 1/2" OD set at 3800' with 900 sacks, top of cement to be determined by temperature survey.

Permission is requested to produce this well upon completion.
