Ran 3130' of 5 1/2" 17# and 15.5# casing set at 3136'. Used 450 sacks cement, 3% gel, 200 at shoe, 250 thru 2-stage tool set at 1435'. Plug down 3:30 AM 1-5-53.

Drilled 2-stage tool, cement and float collar to shoe. Applied 750# pressure and held for 30 minutes. Shut off okay.

Note: Additional casing was used to have casing seat in brown lime.
