Gentlemen:

It is respectfully requested that the Oil Conservation Commission grant an exception to No Flare Order R-553 as it pertains to Cities Service Oil Company's Closson "B" No. 10 in the Jalant Pool, Lea County, New Mexico. In support of this application we wish to state the following:

1. Cities Service Oil Company is the owner and operator of the Closson "B" Lease consisting of 1822.04 acres and is comprised of the W/2 of Section 18, Section 19; W/2 of Section 20 and Section 30, Township 22 South, Range 36 East, Lea County, New Mexico. The No. 10 well is located 1980' PSL and 610.8' FWL, Section 30 and was completed September 25, 1956.

3. The initial potential on the Closson "B" No. 10 was 50.8 barrels oil, 380.7 MCF gas in 8 hours for a gas-oil ratio of 7495 to 1. On retest November 1, 1956, the well produced 48.9 barrels oil, 376.4 MCF gas in 8 hours for a gas-oil ratio of 7697 to 1. At present daily allowable of 36 barrels per day, the volume of gas to be flared will be approximately 277 MCF per day.
4. Efforts have been made and are being made to connect the Closson "B" No. 10 to a low pressure gas gathering system.
5. A plat showing the well location, offset ownership and tank battery location is attached.

In view of the foregoing statements and to keep this well on production to protect correlative rights, it is requested that the Oil Conservation Commission issue an exception to its No Flare Order R-553 for a volume of approximately 277 MCF per day, which will be wanted from the Cities Service Oil Company Closson "B" No. 10 pending a connection to a low pressure gas gathering system.
