The subject well is presently shut-in due to excessive gas-oil ratio of 753 MCF per barrel of oil.

It is proposed to recomplate the subject well as a Yates gas well by setting a bridge plug at 3450', squeezing the perforations now open from 3470' to 3476' and 3484' to 3490' with cement, and perforating the Yates formation in the interval from 3200' to 3370'.

Permission is requested to perform this work as outlined.

A subsequent report will be filed upon completion of the above work.
