DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Wellhead casing pressures instead of tubing pressures were taken with a dead weight tester to eliminate the calculation of friction in the producing string. The volume of gas was measured with the differential pressure recorder on the El Paso Natural Gas Company's meter run. The resulting ABSOLUTE OPEN FLOW IS 5,750 MCF/24 HRS.
