It is intended to drill this well with rotary tools at the above location to an estimated TD of 3800'. Casing will be set in accordance with U.S.G.S. standards and other special requirements will be complied with.

The following casing pattern is planned: 8 5/8" OD set at 350' with 350 sacks, cement to circulate; 5 1/2" OD set at 3800' with 900 sacks, cement to return to 1300'.
