DETAILS OF WORK

It is intended to drill the above well with rotary tools to an estimated TD of 3800'. Casing will be set in accordance with USGS standards and other special regulations will be complied with.

The following casing pattern is planned: 8 5/8" OD set at 350' with 350 sacks, cement to circulate; 5 1/2" OD set at 3800' with 900 sacks, cement to return to 1300'.

Permission is requested to produce this well upon completion.
