2. Clean out cellar, check corroded surf csg & repair.
3. Run Vertilog. Run RBP, set BP @ 3501'. Run CBL, perf 5 1/2" csg from log @ approx 1920-22'. Spot sd on BP.
4. RIH w/cmt retr, set retr @ 1800'. Squeeze cmt perms w/400 sx C1 C cmt & 175 sx C1 C cmt w/2% CaCl. Circ to surf. WOC.
5. Drill out cmt & cmt retr. Pressure test squeeze job to 1500# for 30 mins.
6. Circ sd off BP & POH w/BP @ 3501'. Circ hole clean.
7. RIH w/compl assy. Install larger pmpg equip, return to production.
