DETAILS OF WORK

It is intended to drill this well with rotary tools at the above location to an estimated TD of 3815'. Casing will be cemented in accordance with U.S.G.S. standards and other special requirements will be complied with.

The following casing pattern is planned: 8 5/8" OD set at 350' with 350 sacks, cement to circulate; 5 1/2" OD set at 3815' with 1100 sacks, cement to return to approximately 1250'. Actual amount of cement used on production string will be determined from caliper survey.

Permission is requested to produce this well upon completion.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
