Cemented 123 jts, 3788', 4-1/2" OD 9.50# J-55 SS casing at 3800' with a total of 285 sacks cement. Used 135 ax Maryneal 16% Gel, 3% salt, 5/10% BJ retarder followed with 150 sacks Regular Incor cement. Plug at 3785'. Maximum pressure 1500#. Complete 11:00 a.m. 2-5-61.

After waiting over 24 hours, tested 4-1/2" casing with 1000# for 30 minutes. No drop in pressure. Did not drill out plug.



