4. Treated w/11,000 gallons lease crude containing 1 1/2# sand & 1/40# Mark II Adomite per gallon in 3 stages using ball sealers.
5. Ran 120 jts. (3718') 2" upset, 8rd thd, J-55 tubing & hung @ 3727'.  
2" Seating Nipple @ 3697'.
6. Recovered load.
7. On OPT flowed 167 BOPD + 9 BOPD (based on 41.8 BO + 2.2 BW in 6 hours) thru 20/64" choke. FTP 525 psi. CP 700 psi. Gravity 32.1 deg. API.


