A Worth Well Temperature Delta Log Survey indicated gas channeling from 3578' to top of perforations at 3622'. It is proposed to plug back to approximately 3616' with pea gravel, sand and hydromite, perforate casing at 3611' with a four-way jet, run cement retainer on tubing and set at between 3542' and 3568'. Squeeze cement. WOC. Drill out to original PBD 3772'. Return well to production.
