1. MIRUPU. Pull rods and pump. Install BOPE. Pull tubing.
2. Perforate additional Seven Rivers at 3650'-62' and 3670'-84'.
3. Run plastic coated injection packer and tubing. Set packer at 3550'(+) Load 2 3/8" - 7" annulus w/1% KCL water containing 1% Tretolite KW-37 and 5% Tretolite K-470.
4. Install surface injection equipment & commence water injection.
