DETAILS OF WORK

It is intended to drill a well at the above location with rotary tools to a depth of 3750' in the Queen formation. Casing will be cemented in accordance with USGS regulations and other special requirements will be complied with.

The following casing program is planned: 7 5/8" OD set at 350' with 200 sx, cement to circulate to surface; 4 1/2" OD set at 3750' with 725 sx, cement to return to 1350'.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
