4. SOT with 20,000 gal. refined oil, 60,000# sand w/500# Adomite.
5. Pulled 3" tubing and packer.
6. Ran 110 jts. (3439') 2" EUE 8Rd tubing with seating nipple.
7. Connected up to test tank. Recovered 16 bbls. oil.
8. Reconnected to El Paso Natural Gas Company's intermediate line and ran four-point back pressure test.


