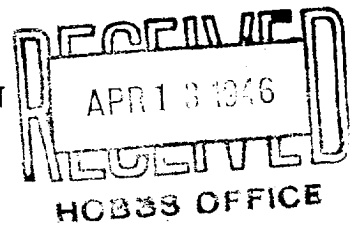

## FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Permission is hereby requested to install gas lift, connecting outside gas from the Eunice Gas System, at our Alice Paddock #3. The Eunice Gas System receives gas from W. A. Ramsay #1 gas well, which produces from the Yates and Seven Rivers formations; and from our H. T. Mattern #1 gas well, which produces from the Queen and Grayburg formations. The W. A. Ramsay #1 gas well is located in SW 1/4 of Sec. 34, Twp. 21 S, Rge. 37 E. The H. T. Mattern #1 gas well is located in SE 1/4 of Sec. 24, Twp. 21 S, Rge. 36 E.

The work will be done immediately upon approval.
