FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

On September 20, 1945 the 7" O.D. Casing was set in Line at 5,157' and cemented by Halliburton Oil Well Cementing Company with 300 sacks of 2 1/2" Aquagel and 100 sacks of Heat cement. The plug was pumped to 5100'. The job was started at 5:00 P.M. September 19th, and completed at 1:30 A.M. September 20th.

7" O.D. Casing as follows:

112 jts. 7" O.D. 8 Rnd. Thd. 23 1/2" S-80 Range 3 New S. S. Casing set at 5,157' (Tallies 5,146' - Cellar 11')

Propose to drill plug and test shut off at 1:30 A.M. Sept. 23, 1945.
