Production prior to acidizing 21.52 BOPD, Water 0, GOR 1983.

9-20-52 - Treated with 2350 gallons of Cardinal Jel Jet 99 (with oyster shells in last 800 gallons)

9-21-52 - Treated 5088-5193 with 10,000 gallons Cardinal 15% L. T. Acid. Maximum and minimum tubing pressures 1750 to 1600#. Spotted 252 gallons Cardinal Jellite blocked formation.

9-28-52 - Swabbed well 10 hours, recovered 44 barrels fluid, 50% BS&W. Formation lime.

10-11-52 - Tested 24 hours pumping 11 - 44 strokes per minute, produced 68.81 barrels oil plus 2% BS&W, GOR 2124.
