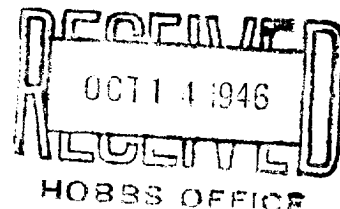


## OIL CONSERVATION COMMISSION
