Acidize producing interval with 10,000 gallons as follows:

1. Pump in 50 ball sealers.
2. 3,500 Gallons acid followed by 100 ball sealers.
3. 3,500 Gallons acid followed by 100 ball sealers.
4. 3,000 Gallons acid.

Current producing interval: Perforated casing from 5085 to 5190.

Latest production test: 24 hours, pumping, 10 barrels oil, 4 percent water, GOR 3792.
