Brunson "B" Well No. 8 is producing from the Paddock Pool (Glorietta Formation). The Well is currently producing its penalized allowable of 22 barrels. Acid has been used periodically to increase production. It is proposed to treat this well with Che-Plex, a sulphate dissolving agent. It is believed that this will increase production by cleaning-up the bottom of the hole and permit better channeling of oil in the formation.
