**Total depth 2810' anhydrite. Ran 89 joints of 8 5/8" O. D. H-40 SS Casing, 2796' set at 2808' and cemented with 500 sacks. Plug down at 6:00 AM, May 15, 1947. Cement was allowed to set 30 hours, plug drilled out 1000# pressure applied with no drop in pressure. Drilling resumed.**
