Total Depth 6522' Lime. Ran 206 jts. 6415.18' of 5-1/2" OD casing set at 6425.45' and cemented with 350 sax. Plug down 5:25 P.M. October 7, 1949. Cement was allowed to set 48 hours, plug drilled out, 1000# pressure applied with all valves closed, no drop in pressure. Drilling was resumed.
